AANR's International Convention Is a Hybrid of Live and On-Line Participation

The AANR International Convention was held August 11-13 at Star Ranch Nudist Resort in Texas. The convention was supposed to be held there in 2020, but that event was converted to a ZOOM videoconference. This year the convention was held in person but with a videoconference option for those who wanted to attend remotely. The consensus is that all future AANR meetings will be a combination of live and remote in order to increase participation by the membership.

The sessions each day lasted about four hours so that the host club could present different sports events and workshops. The Wednesday session was devoted to committee reports. The annual awards for given out on Thursday morning for such things as Best Club Newsletter (won this year by the Buff-a-teer club in Tucson, AZ), best television and radio news story, Scholarship awards, etc.

The two people inducted into the AANR Hall of Fame this year. Bob Morton, from AANR's Southwest Region (and former NAC Executive Director), and Morley Schloss, owner of the SunSport Gardens club in Florida.

1. Behavior Guidelines and Non-Discrimination

The WINR committee announced there is a poster available to assist those made to feel uncomfortable at an event.

A motion was defeated to list the clubs on the aanr.com website who endorse the AANR non-discrimination by-law. The Trustees felt each club, as an individual business, should have the right to decide if it allowed children, alcohol, singles, etc. but that any restrictions should be listed on the club's Impexium club page so that guests can see them and decide ahead of time whether or not to visit that club.

However, the Trustees unanimously agreed to accept the new social media guidelines as presented by the Public Relations and Membership Marketing Committees.

2. Future Meeting Locations and Reimbursements

The 2022 convention will be held at Suwanee River Resort in the Florida panhandle. The convention selected Solair Family Nudist Resort in Woodstock, CN for its 2023 summer convention.

A motion was approved to raise the room reimbursement rate for the Trustees attending meetings from a maximum of \$85 to \$120 per night "to reflect realistic lodging costs." Air fare and car rental reimbursements were also raised. This is effective in 2022. Non-trustees still will have to pay the going room rate at the nudist park or at a nearby hotels.

AANR West Region Sees Membership Numbers Rise After a Year of Covid Declines

During the first six months of 2021, the Western Region has gained back about half of the members it lost during all of 2020 during the peak of the COVID pandemic, when many clubs were closed. The AANR main office released these numbers during the first week of August.

The full AANR organization also saw a rise in its membership. After suffering a loss of 11% between December 2019 and December 2020, AANR has regained about 900 members through June 30, which is a 4% gain for the year. AANR now has 28,700 members across all regions and countries. This trend is also being seen in other non-profit industries as people begin to return to their normal lives. Here are the numbers by club and by state for our Western Region:

AANR Promotes New Anti-Harassment Posters for Clubs

While it has never been a large problem at clubs, personal harassment does happen from time to time at the clubs. So AANR is doing something about it.



This month, the organization is asking its clubs to display a poster in its club restrooms giving instructions for whom to talk to in case a member or visitor feels they are being harassed either sexually or ethically or for any other perceived reason. AANR takes such violations of its anti-discrimination By-Law very seriously after hearing of a few cases around the country with those feeling they had nobody in authority to talk to. The poster provides several ways for people to take the next step should they chose to do so.

Margie Cantlon, AANR VP and owner of Sun Meadows Ranch in Idaho said she has had a couple of complaints since she posted a draft of the poster in her restrooms a few months ago, and the incidents were quickly resolved. "Usually, the problem is a guest who doesn't understand our behavior guidelines," she told the AANR convention. Our women members feel very positive about the results."

Margie agreed men can be harassed also, especially about sexual orientation. A separate poster is available for them.

An 8 x 11 size version for AANR-West is being sent to all clubs in our 8-state region with this newsletter. Copies of an 11 x 13 poster are available from the AANR office by request.

AANR Hosts "Raising Children in Nudist Home" Webcast



On August 21, the AANR main office hosted another in its series of ZOOM webcasts on issues of interest to the nudist community. This hour-long session was on "Raising Children in a Nudist-Friendly Environment." It consisted of Erich Schuttauf, AANR's Executive Director,

and President Kathy Watzel talking about their own experiences raising their families in clothing-optional households, along with some Q&A from the 52 people who were on the call.

Erich recommended the humorous picture book "Naked," written by comedian Michael Ian Black. The book is for children (available on Amazon) about a boy who refuses to wear clothes. It explains to kids the fun of being naked, and when it is not appropriate.

Viewers asked questions about how to handle the topic with disapproving relatives or nosy neighbors or curious outside playmates, and also family legal issues. One viewer suggested all clubs designate a **Family Weekend** each month so parents with children know there is a good chance to meet other families, and so their kids can play together.

New Apple Child Protection Policy Raises Privacy Concerns

On August 6, Apple confirmed it had developed a new program for its iPhones to combat child sex abuse materials (CSAM), including implementing technology that will detect nude images on personal phones or uploaded to the iCloud. Apple will now automatically block someone searching for these images online either directly by using Search, or through Siri. Apple will allow parents to implement a program on their children's iMessages that would blur any images with nudity. It will also alert parents if the child chooses to view the image or send nude images themselves. The announcement said the program will be released in the US later this year.

A week later, Reuters reported that more than 90 policy and civil rights groups around the world published an open letter urging Apple to abandon their plans for scanning children's messages for nudity and the phones of adults for images of child sex abuse.

"Though these capabilities are intended to protect children and to reduce the spread of child sexual abuse material, we are concerned that they will be used to censor protected speech, threaten the privacy and security of people around the world, and have disastrous consequences for many children," the groups wrote.

Signers of the letter included the American Civil Liberties Union, Electronic Frontier Foundation, Privacy International, as well as other civil liberties groups from in India, Mexico, Germany, Argentina, Ghana, Brazil and Tanzania.

The signers said the policy change could endanger children in intolerant homes or those seeking educational material. "This technology could "out" LGBTQIA+ kids to their parents, potentially placing them in both psychological and physical danger." Also, US teens are sexually active before the age of 18— and that "sexting" is not uncommon among teenagers. This technology, then, potentially infringes on teens' right to sexual autonomy. It could also potentially open up charges of distributing child pornography against the children,

"...Or let's say a woman wants a divorce from her husband. He grabs her phone, activates this, sees she's sexting a new partner, and uses the images against her in revenge porn. I can promise you that will happen with this technology."

"...Once this backdoor feature is built in, governments could compel Apple to extend notification to other accounts, and to detect images that are objectionable for reasons other than being sexually explicit," the letter says. "We feel very confident this technology could be used to spy on people in other countries."

The nudist community has not yet come together to issue a common response but there are private concerns voiced within the leaders of various nudist organizations and clubs that this new program will affect the ability of such organizations to communicate with its members through shared photos, newsletters, websites, or blogs.



Appellate Judges Uphold Ocean City's Topless Ban

August 4, 2021 - A federal appeals court on Wednesday affirmed a Maryland beach town's right to ban women from topless sunbathing.

A three-judge panel of the 4th U.S. Circuit Court of Appeals in Richmond ruled unanimously that Ocean City's law, which allows men to be topless but not women, is constitutional.

Ocean City passed its law in 2017 after one of the plaintiffs in the case, Chelsea Eline, contacted Ocean City police and asserted a right to go topless.

The panel's ruling notes that courts across the country have upheld laws banning women from topless sunbathing on public beaches. While the law imposes a restriction on women that is not imposed on men, Judge A. Marvin Quattlebaum Jr. wrote that Ocean City's elected leaders are within their rights to enact laws that protect public sensibilities.

"The judicial legacy of justifying laws on the basis of the perceived moral sensibilities of the public is far from spotless. Some government action that we now rightly view as unconstitutional, if not immoral, has been justified on that basis. Even so, in this situation, protecting public sensibilities serves an important basis for government action," Quattlebaum wrote.

Town leaders said they received calls and letters overwhelmingly supporting the ban.

In a concurring opinion, Chief Judge Roger Gregory wrote that U.S. Supreme Court precedent requires upholding the ban. But he suggested the court should reconsider the issue.

"At first glance, Ocean City's ordinance seems innocuous enough. ... But we must take care not to let our analysis be confined by the limits of our social lens," Gregory wrote. "Suppose the ordinance defined nudity to include public exposure of a woman's hair, neck, shoulders, or ankles. Would that law not run afoul of the Equal Protection Clause?"

"The plaintiffs relied on one court decision from the district of Colorado that favors their position," prosecutors said after the decision. "The Colorado decision [Free the Nipple v. Fort Collins] appears to be an outlier, given the various decisions in both federal and state courts that do not favor the plaintiffs."

Glen Eden Announces its 5th Annual Sabroso Latin Festival, September 17-19 Weekend

After a COVID hiatus in 2020, Sabroso is back in 2021 with the theme of "Latino Rhythms- Flavored in Traditions and Cultures." The focus this year is on the various types of music that originated and have evolved in Latin America, and which now permeate much of the pop music being produced today. These musical influences include Reggaeton, Salsa, Cumbia, Tango and Batacha. The festival this year also includes a home-grown band named Sabor ("flavor" or "taste") composed of members of Glen Eden, and which will perform a varied assortment of favorite Latin rock songs. This year's schedule can be found on the poster above.

"Sabroso" is a Spanish word that means exquisite, rich, flavorful, and savory. Often used to describe a mouth-watering meal, in the Latin American culture it is also used to describe any experience that brings delight.

The Sabroso Festival's intent and purpose is to entertain and educate about the different customs, music, and history of these various countries. Nearby Fires Restrict Access to Nudist Outings in No. Calif and Nevada

As of August 31, the Tamarack and Caldor fires have destroyed more than 500 homes, burning through rugged terrain from east of Sacramento toward Lake Tahoe. They have grown in two weeks to more than 190,000 acres. They are now approaching South Lake Tahoe, requiring evacuation of residents there.

This worsening development has affected the plans of several nudist groups in the area including Northern California Exposure, Northern Nevada Naturists, and Tahoe Area Naturists, plus numerous unaffiliated campers and nude hikers.

The smoke has created conditions so hazardous that a temporary area-wide closure of all the national forests California and the Nevada Lake Tahoe Basin. Ash has started falling in the lake and on the beaches, thick enough to leave footprints.

As a result, the beaches along the east shore of Lake Tahoe and camping areas east of Sacramento also have been closed until the Caldor fire is contained. The poor air quality from smoke in the area, all the way to Reno, is considered the worst in the nation at the moment.

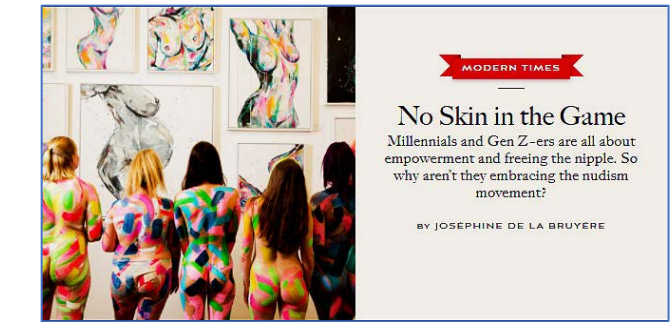

The essence of the article is this sentence: "[Millennials believe] AANR. clubs are unaffordable and passé."

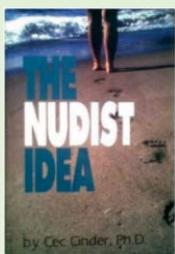

The 1500-word article is certainly worth reading and discussing as AANR clubs continue to seek ways to attract their next generation of members.

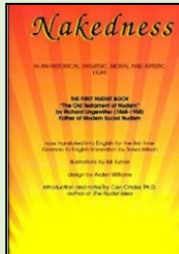

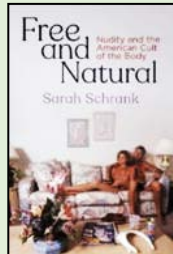

Treehouse hosted Mr. and Miss Nude Universe Contests

87-Year Era Ends As Former Treehouse Fun Ranch / Deer Park Club Property Is Sold

In 1971 Bill and Fran Flesher opened one of the most successful, if controversial, nudist parks of that era. The Treehouse Fun Ranch was born at a remote corner of Devore, California near what is now Glen Helen Regional Park.

Over its 87 years as a nudist-friendly destination, the 40-acre location went through several owners, name changes, and cultures. Few remember that before it was called Treehouse, the nudist-friendly park had been known by many other names since it was originally bought in 1934 by Ray and Helen Barry, who named it **Buckhorn Ranch**, then renamed it **Sunshine Ranchero**. In 1947 it was bought by Jim Campbell and Bill Keisel (later a founder of Olive Dell Ranch) who named it **Oakdale Guest Ranch**. Ten years later it was bought by Mel and Ann Hocker who started the tradition of Nude Pageants at the resort. It retained this name until the Flesher's purchase in 1971.

In its heyday, **Treehouse Fun Ranch** was a mecca for nude recreation in the Inland Empire. Flesher was a master of marketing and his three annual events, a world-class Chili Cookoff, the Miss Nude USA, and the Mr. Nude Universe beauty contests, gave him and his park worldwide recognition.

The cookoff attracted some of the world's best chili chefs (sometimes as many as 40 entries) and it guaranteed thousands of visitors (nudity was not required at the event) and guaranteed media coverage. There was also a wet T-shirt contest that weekend and plenty of country and bluegrass music on the stage, plus contests for Mr. Hot Sauce and Ms. Chile Pepper.

At the Nude beauty contests, outsiders were allowed to bring cameras to photograph the contestants during the judging. This was long before the word "sexist" and "misogyny" were ever used to describe these events. Fun fact: In 1977 the Fleshers were sued by the Miss Universe Corporation, and they were forced to cease using the word "Universe" in their promotional material because, the judge agreed, it caused confusion with the larger international company.

Treehouse regularly hosted ASA (American Sunbathing Association, predecessor to today's AANR) conventions and the Fleshers were seen as leaders of the national nudist movement. They even opened a Treehouse II in Palm Springs

for a short time to handle the overflow seeking overnight accommodations.

By 1996, both Bill and Fran had developed health issues and could no longer adequately manage the property. They fell behind on their mortgage and the banks foreclosed.

The property was renamed **Buff Creek** by the new owners, and they began promoting the place for lifestyle advocates and swingers. All of the national nudist organizations disassociated themselves with the new owners. It only took a few years for them to run into financial difficulty and the property was again sold, this time to Chris Crawford. Crawford was a real estate entrepreneur whose wife had grown up as a nudist on the property. He renamed it **Deer Park** in 1998.

The new managers "cleaned house," trying to regain the support of nearby nudists who had since changed loyalties to nearby Olive Dell Ranch and Glen Eden Sun Club. It was a hard struggle, and despite many land improvements and support from nearby travel clubs, the property never achieved its former glory.



In 2013, Crawford closed the nudist park and leased the land to **Freedom Acres**, a nearby swinger night club looking to expand recreational opportunities for its members. Families were banned from the property and many of the nudists owning mobile homes there sold out to Crawford at huge losses. Freedom Acres made many improvements to the infrastructure, as by now many buildings were quite old. FA seemed to thrive with its infamous pool and foam parties. But the COVID epidemic shut it down and the bills stated to mount. Crawford began looking for a buyer.

A few weeks ago, all of that history came to an end as the remaining residents were notified that they have 30 days to vacate to property to make way for a new truck stop. The new property owners, rumored to be an oil company, are going to tear everything down at the site and start over, according to the written notice. There was no prior warning, residents said.

Freedom Acre members are naturally angry and are searching for a way to stop the sale, but it seems the residents are out of time. They either find a way to move their mobile homes or else lose a substantial part of their investment there. Many are of retirement age and really have nowhere to go.
