## **Setting Priorities for the Coming Year**

The President went around the room asking for ideas and priorities for the coming year. After the Board was asked, the discussion was opened to the audience in attendance.

- Club Liaison Program. Ernie: Better wants to see participation from clubs. He will work on liaison program, and a new scholarship brochure;
- Treena: We need to contact clubs throughout the year regarding credentials for better representation;
- Don: Social Media is a subset of PR and could be one committee, reduce dependency on email;
- Rolf: Budget requests deadline is Sept 23, figure what you want and then put a price tag;

- Claudia: I will work on a new women's brochure, a general brochure in Spanish, a kids' brochure, all w/ fresh photos;
- Walt: Possible AANR travel agency or property sharing to promote NAKATIONS<sup>TM</sup> in the marketplace;
- Andy: Most committees could fall under a Marketing umbrella, monthly Go-to-Mtg is essential;
- Jeff: Reach out to clubs w/ personal visits or call;
- Cyndi: Budget to get a thorough review for discipline of spending, collect spiffs for passport raffle;
- Barry: Looking forward to contributing to the upcoming budget process;
- Ricc: Fight apathy at clubs with liaison programs and marketing, order tchotchkes through AnyPromo.com.
- More use of the "Two Dollar Bill" programm to promote awareness in community of our presence; Cyndi: Shangri La Ranch has printed introductory cards and leave them at restaurants. She will get everyone master copies. Russell prefers we use a stamp to deface the bills (Secretary's Note: Review US Title 18, § 333).

Additional ideas for committees and in general (no specific order):

- WNRL asks clubs to encourage members to bequeath the library in their wills, donate photos;
- Support/subsidize club youth camps instead of regional camps to better serve local children;
- Social Media Committee to encourage more on-line use by clubs;
- Scholarship Committee will create a new brochure for distribution at all clubs;
- Ernie: Recruit vocational education teachers at MOUNTAIN AIR RANCH to assist.
- Reduced club gate fees for families bringing in children;
- Legislation for next year: Move committees from By-Laws to Procedure Manual, combine or create new ones;
- Liaison Committee to possibly attend club "town hall" meetings to talk w/ members directly;
- Form partnership w/ college film students to video local parks and activities for web site;
- Form a Speakers' Bureau for local service clubs and college classes;
- Finance Committee to look for additional revenue sources aside from membership dues;
- Expand trade show participation to increase public awareness;
- Establish sub-regional inter-club sports teams to then compete at festivals for trophies;
- Directly send The Western Sun newsletter to members whose club are not forwarding it;
- Create/fund on-line meet-up sites for non-landed clubs;
- Create "AANR Kids" Facebook page to promote special events (bike rides, art projects, &c.);
- Additional pioneer biographies on the website w/ information supplied by clubs.
