## Important AANR Announcements

### AANR Membership Dues Will Increase January 1

Your AANR member dues will increase by \$6 on all renewals as of January 1. Also, couples will be split into individual memberships after that date.

Individual members and clubs collecting dues that are due for December 2019 under the old rates must be postmarked to the AANR office no later than January 15, 2020.

AANR dues for new and renewing memberships that are effective January 2020 must include the \$6 increase, and all notices to clubs and Associate members will reflect that increase.

The increase was approved at the national AANR convention last August. It has been eight years since the last dues increase and the organization needed to make the change to cover rising costs and a budget shortfall.

### Are You Ready for a 'Nakation®'?

Travel trends come and go from eco travel to medical tourism, spiritual travel to tornado tourism. One of the latest trends appears to be all about stripping things down to the basics. And I mean that literally.

The "Nakation®" aka clothing-optional tourism is becoming one of the fastest-growing segments of the travel industry. Shirking that outer layer at nude beaches and resorts and even on clothing-optional cruises has become the vacation choice du jour for hundreds of thousands of free-spirited Americans.

Travel industry experts suggest that nude recreation is fast becoming a billion dollar-a-year industry. It's certainly bringing in big bucks in Florida, where the state's tourism department reports that nude recreation made a \$7.4 billion economic impact in the Sunshine State last year.

Mature adults, 45 and older, make up the majority of Nakationers®, according to Mary Jane Kolassa, media relations representative for the American Association for Nude Recreation, or AANR, the oldest and largest advocacy group for nude recreation in North America.

"The demographics are shifting, however," says Kolassa. "We're seeing more millennials, Gen Xers, African Americans and Hispanics opening up to the joy and freedom offered by the nude travel experience."

Behavioral scientists theorize that the appeal of nudism may relate in part to the need in our increasingly complex world for "tech detoxing" and going "off the grid" as remedies for the frenetic modern lifestyle. Ditching the duds, they reason,

be one more way to simplify the chaos. Egalitarianism comes into play as well: without the trappings of clothing, it's hard to stereotype someone as "blue collar" or "white collar" when there are no collars.

For those uninitiated to the rites of undressing in public, here's some soothing encouragement from Gigi Engle, a certified sex coach and educator at California's Alexander Institute. "Don't let yourself feel pressured on an adult lifestyle holiday. You might feel uncomfortable at first," Engle says, "but once you see so many people of all ages, shapes and sizes just living their lives in the nude, it becomes normalized very quickly."

The various kinds of Nakations® advocated and promoted by AANR at the organization's nearly 200 member clubs across the country take their cue from naturism the wholesome, lighthearted joy of nudity without the sexual debauchery that one might envision.

"Simply put," says Kolassa, "our mission is to advocate nudity and nude recreation in appropriate settings while educating and informing society of their value and enjoyment."

That's not to say there aren't plenty of options for those wanting to kick it up a notch. Resorts catering to the sexually adventurous such as Hedonism II in Jamaica; Desire Resort & Spa in Cancun; Rooftop Resort in Hollywood, Fla.; and Live Oak Resort in Washington, Texas, are popular bucket-list spots for swingers.

Nakations® needn't be confined to resorts. Nude cruises are becoming a really big thing. There are several travel agencies, such as Castaways Travel and Bare Necessities, that charter entire vessels for clothing-optional cruises. Castaways co-owner Donna Daniels estimates that her company will book about 7,500 passengers this year on three chartered voyages operated by Celebrity and Royal Caribbean Cruises.

"The cruise lines set the itineraries, of course," says Daniels, "but we organize special activities for our clients, including costume nights, body painting and adult comedians."

## Government Affairs

### Colorado Town Awards \$50 K to Topfree Woman

Efrosini "Effie" Krokos, 20, has been paid \$50,000 and had all charges dropped in the city of Loveland, Colorado after she was cited for playing Frisbee topless in her front yard on Sept. 26, reports KDVR-TV in Denver.

City officials were quoted saying they thought they could not win after the recent 10th Circuit Court of Appeals ruling [*See our November AANR-West newsletter – Editor*].

Krokos says her actions weren't calculated. "I didn't do this for the money," she explains. "I did it just because I thought I was equal to a guy."

Loveland has an ordinance prohibiting the exposure of breasts in public, but police will suspend enforcement until city council can review it, KDVR reports.

The \$50,000 settlement is the first damage claim paid to a woman wrongfully charged for being topless in the US.

## A History of Nudism and Government Censorship, Part 1: 1873-1980

In our modern age, it's easy to talk with other people about nudism, or share photos of nudist activities.

- Send an email.
- Send a text.
- Make a FaceTime call.

Granted, there are relevant ethical and privacy issues (a subject for another article at another time) but for consenting adults wishing to communicate about nudism, today's technology makes it easy.

This was not always the case, of course. As we work with the Western Nudist Research Library collection, we are continually reminded about the risks that were presented in past years when someone wanted to write about nudism or publish and circulate a magazine with stories and nude photos for other people to see.

In 1873, the **Comstock Act** made it illegal to mail any publication that was "obscene," "lewd" or "lascivious." This definition included anything portraying nudity, as well as any materials that discussed sex, sex education or birth control. Violators of the Comstock Act were guilty of a felony offense. The Comstock Act had a tremendous influence on American social mores.

In 1957, the U.S. Supreme Court decision in **Roth v United States** upheld the U.S. Code (18, § 1461) further restricted free expression and publication in America, making the following actions illegal:

*Every obscene, lewd, lascivious, indecent, filthy or vile article, matter, thing, device, or substance... which is advertised or described in a manner calculated to lead another to... any indecent or immoral purpose... Every paper, writing, advertisement, or representation that any article or thing may be used for... any indecent or immoral purpose... Is declared to be a non-mailable matter and shall not be conveyed in the mails or delivered from any post office or by any letter carrier.*

The U.S. Code called for violators to be fined and imprisoned for up to ten years.

In 1973, the "Miller test" for obscenity was established by the U.S. Supreme Court. In the case of **Miller v California**, the court ruled that any publication that lacks "serious literary, artistic, political, or scientific value" and "taken as a whole, appeals to prurient interests" is obscene, and thus not protected by the First Amendment.

Looking through the different nudist magazines produced in the early years of the 20th century, it's interesting to see how different publications worked to avoid legal punishment. Some magazines did not show naked people on their front covers. Others airbrushed front cover images to hide

offending body parts. Other magazines chose to use opaque envelopes, stickers or labels to hide content from censors.

Shown to the left are two nudist magazine covers from the 1960s, pulled from the Western Nudist Research Library collection.

Magazines in this time period were filled with images of slim, attractive (mostly white) young women. There were far fewer images of men, and when men appeared, they were usually posed to avoid showing anything between their legs. Full frontal male nudity did not appear very much in nudist magazines until the 1970s.

## Your Western Nudist Research Library's Goal is to Have a Searchable Database of All Published Documents



One of the goals the Western Nudist Research Library and its partner institutions are working toward is a fully searchable database. In other words, a user would be able to access the shared database through any of the five libraries and do a search not

only to locate specific documents or publications by title, but to find documents by key words or names shown within them. It will take quite some time to fully implement this feature.

Most of the items in our electronic collection are saved as PDF files. This format works best because PDFs can be viewed on a variety of computers with different settings and software. PDFs are easily created and shared.

However, in order to make a PDF "searchable" it needs to have the Optical Character Recognition (OCR) feature activated. OCR places a layer of text on top of the image of the document to create a path for the computer to then search for words contained in the document.

OCR was not activated when many of the early nudist documents and publications were scanned and saved into the different library collections. In each of the five libraries, we're now making sure that new scanned materials include OCR, and we're adding OCR to PDF files of earlier materials as time allows.

Of course, just having OCR in place doesn't necessarily mean that searches will run easily or correctly. So, volunteers are also going back through the collections to test and make sure an OCR-enabled search will work as it is supposed to, to deliver the relevant documents identified in the search.

All of this is not a very exciting process, unless you're someone who's enthralled by computer digitization and coding. But it's all part of what we are doing to make sure the history of nudism in North America and around the world is documented for people today, and generations to come.
